Regular Town Board Meeting

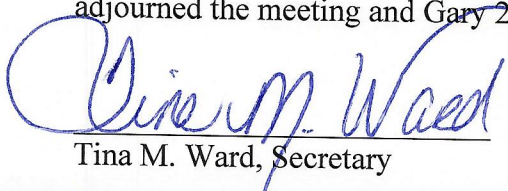
Council President Jim Butler made a motion to waive the minutes of the meeting and was 2nd by Gary Rheude.

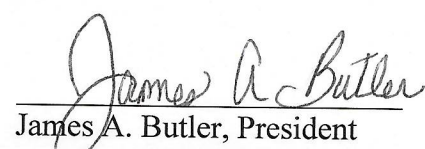
Old Business
