- 1. Building inspector Nothing to report.
- 2. Financial Report Clerk gave financial report. The clerk presented the council with yearend transfers. Trisha made a motion to approve 2nd by Gary. Unanimous. Clerk presented council with wastewater project & community crossing grant to Encumber money from 2023 to 2024. Jim made motion 2nd by Trisha. Unanimous. The clerk had a quote from John & Cheryl Durham to take care of the park (this is an ongoing bid) for \$6,500.00 per year, they would like to be paid quarterly. Trisha made a motion to approve 2nd by Gary. Unanimous. The clerk presented the council with the financial packet for the month. Jim made a motion to sign financial packet and it was 2nd by Gary. Unanimous.
 - 3. Fire Department Report Fire chief was not present due to illness.
 - 4. Police Department Report Dillon presented the council with 66 calls, 32 handled by Goodland police, 1 arrest, 5 warnings, 5 ordinance violations. Dillon stated he will be going to court on January 16, 2024, for ordinance violations.
 - 5. Street and Water Dept.- Street signs have been installed. Town & Country came in at the lowest bid. Christmas lights and banners were put up. Leak at the water treatment plant that needs repaired. Rod Green has offered to help with it while his equipment is on site. We have installed a new heater at the well 1 and 2 building, along with plumbing repairs.
 - 6. Sewer Department Routine testing and reporting as per IDEM/EPA regulations. Dustin presented the council with quotes for a new cab chassis 3500 1 ton \$48,479.00, Rowe Trucking has a bed that will fit the cab chassis for \$12,477.74. Jim made a motion to accept those quotes and Trisha 2nd. Unanimous. Dustin had a quote for a new Backhoe John Deere for \$152,900.00 or Case for \$132,350.00. Jim made a motion to approve the Case quote for \$132,350.00. 2nd by Trisha. Unanimous.

- 7. Attorney's Report Jud had several ordinances for the council to pass. Delinquent account will be charged 10% late fee across the board. Ordinance to confirm Funds, ordinance to establish residential TIF fund, ordinance for water/wastewater transfers, Residential for taxable economic development note 2023 fund. Jim made a motion to approve 2nd by Gary. Unanimous.
- 8. Kaitlyn Williams at 306 S Benton Street sent a letter to ask for sewer adjustment because she had a leak. Jim made motion and Gary 2^{nd} . Unanimous.
